COVID-19 NOBIVAC® RELIEF PLAN

Merck Animal Health recognizes these are challenging times. While we practice physical and social distancing, many dogs and cats in the United States may be late returning for vaccination. Considering this unexpected situation, Merck Animal Health is pleased to introduce the COVID-19 Nobivac® Relief Plan.

For adult animals that may develop the disease directly related to not receiving a booster dose due to COVID-19, Merck Animal Health will provide the following support*:

Dogs: Cost of diagnostics and treatment up to \$1000 if a dog is diagnosed with canine distemper virus, canine adenovirus type 1 or 2, or canine parvovirus within 6 months past their scheduled booster (i.e., up to a maximum of 3 years and 6 months since their last vaccination). Cost of diagnostics and treatment up to \$1000 if a dog is diagnosed with leptospirosis, Lyme disease, enteric coronavirus, canine influenza virus (H3N2 and/or H3N8), parainfluenza, or *Bordetella*, within 3 months past their scheduled booster (i.e., up to a maximum of 1 year and 3 months since their last vaccination).

Cats: Cost of diagnostics and treatment up to \$1000 if a cat is diagnosed with feline rhinotracheitis, calicivirus, or panleukopenia virus within 6 months past their scheduled booster (i.e., up to a maximum of 3 years and 6 months since their last vaccination). Cost of diagnostics and treatment up to \$1000 if a cat is diagnosed with feline leukemia virus within 3 months past their scheduled booster (i.e., up to a maximum of 2 years and 3 months since their last vaccination). Cost of diagnostics and treatment up to \$1000 if a cat is diagnosed with feline Chlamydophila or Bordetella, within 3 months past their scheduled booster (i.e., up to a maximum of 1 year and 3 months since their last vaccination).

Provisions for the COVID-19 Nobivac® Relief plan:

- Support is applicable to pets diagnosed between April 1, 2020 and November 30, 2020. All claims must be submitted no later than December 15, 2020.
- This program is valid only in the United States and applies to the Nobivac® vaccines mentioned within this document. The vaccines must be administered by or under the supervision of a licensed veterinarian with an established client-patient relationship and purchased directly from Merck Animal Health or from an authorized distributor purchasing directly from Merck Animal Health.
- Veterinarians must contact Merck Animal Health's Technical Services Department at 1-800-224-5318 to discuss the diagnostics and treatments eligible for this Relief Plan.
- For questions regarding future vaccination protocol for healthy dogs and cats that have missed a scheduled vaccine due to the COVID-19 situation, please contact Merck Animal Health at 1-800-224-5318.
- Documentation of vaccination records must be maintained on file by the
 veterinarian and be available for review by Merck Animal Health. Vaccine
 records should include, at a minimum, the vaccine brand, serial number,
 and the date(s) of vaccination.
- For the program to be valid, the main point of contact must be a veterinarian or an appropriate veterinary health care team member.
- Program coverage may be subject to confirmatory diagnostics. Merck Animal Health is not responsible for lost diagnostic samples. Inconclusive results will be handled on a case-by-case basis.
- For the Relief Plan to be valid, all pets must have completed an age-appropriate initial vaccination series and received a 1-year booster, if appropriate.
- The most recent vaccine must be a Merck Animal Health vaccine.

This Relief Plan applies to the following:

For adult dogs who have an appropriate vaccination history as per label with Nobivac® Canine 1-DAPPv, Nobivac EDGE™ DAPPv, Nobivac® Canine 1-DAPPvL2, Nobivac® Canine 1-DAPPvL2+Cv, Nobivac® Canine 1-Pv, Nobivac® Puppy DPv, Nobivac® Canine Flu H3N8. Nobivac® Canine Flu H3N2, Nobivac® Intra-Trac® Oral Bb, Nobivac® Intra-Trac® KC, Nobivac® Intra-Trac® 3, Nobivac® Intra-Trac® 3 ADT, Nobivac® Canine 1-Cv, Nobivac® Canine 1-DAPPv+L,, Nobivac EDGE™ DAPPv+L, Nobivac® Canine 1-DAPPv+Cv, Nobivac® Canine 3-DAPv, Nobivac® Lepto,, Nobivac EDGE[™] Lepto₄, Nobivac[®] Lyme, and Nobivac[®] Canine Flu Bivalent. All rabies vaccines are excluded.

For **adult cats** who have an appropriate vaccination history as per label with Nobivac® Feline-Bb, Nobivac® Feline 1-HCP, Nobivac® Feline 1-HCP+FeLV, Nobivac® Feline 1-HCPCh, Nobivac® Feline 1-HCPCh+FeLV, Nobivac® Feline 3-HCP, and Nobivac® Feline 2-FeLV. All rabies vaccines are excluded.
